  - 4. CRI Completion Certificate for BPT Candidates.
  - 5. Community Certificate, if applicable.
  - 6. Nativity Certificate, if applicable.
  - 7. Evidence for date of birth (H.Sc / S.S.L.C. / College relieving / Extract from Service Register).
  - 8. Eligibility Certificate issued by the Tamilnadu Dr. M.G.R. Medical University, for candidates graduated through other universities.
- II. If you do not report to the Head of the Institution to which you are allotted on or before the time and date specified, your selection and / or admission will be cancelled without any further notice.
