I. GENERAL INSTRUCTIONS:-

1.1 a) Candidates seeking admission to B.Pharm (Lateral entry) should submit the online filled application form with necessary enclosures which should reach:-

The Secretary, Selection Committee, No.162, Periyar E.V.R High Road, Kilpauk, Chennai – 10.

on or before 25-10-2019 before 5.00 p.m.

- b) The candidates shall ensure that the filled in online application form along with enclosures reaches the Selection Committee within the date and time specified i.e., on or before 25-10-2019 at 5.00 P.M. Applications received by speed post/ courier or any other means after the last date & time will not be accepted, irrespective of the date of booking.
- c) The Selection Committee shall not be responsible for any delay in the receipt or for the loss in transit of application form etc.,
- d) Request for extension of time for submission of documents called for, after the specified date and time will not be entertained.
- e) Applications without required documents / particulars or any supporting documents received after the due date will not be entertained.
- f) Candidates seeking admission under Special Category under Orthopaedically Physically Disabled shall submit a separate Special Category Form along with the online filled application in the prescribed format available along with an additional fee of Rs.100/- by way of a Demand Draft or via bank portal. If the Certificates are not enclosed by the candidates, they will not be considered under the special category without any intimation to the candidate.
- g) Candidates selected under General Category will not be allowed to claim very same status as the candidates selected under Special Category and vice versa.
- h) Both **upper limbs, vision and hearing should be normal** for all candidates including for candidates applying under orthopaedically physically disabled category.
- i) Candidates can track their applications on the websites by entering either their application number (or) +2/Equivalent Examination Reg. No. of first appearance with the year.
- j) All the Demand Drafts should be drawn in favour of the Secretary Selection Committee, Kilpauk, Chennai-10. (Payable at Chennai)
- II. ELIGIBILITY:-
 - 2. Candidate should be a citizen of India.

3. NATIVITY:-

- a) Candidates should be Native of Tamil Nadu
- b) Candidates belonging to other States cannot claim nativity of Tamil Nadu
- c) Candidates who are Native of Tamil Nadu and have studied 8th Std to 12th standard in schools of Tamil Nadu and studied Diploma in Pharmacy course in Tamil Nadu need not enclose the "Nativity Certificate".
- d) Candidates who are Native of Tamil Nadu, but have studied 8th Std to 12th standard and Diploma in Pharmacy course outside Tamil Nadu either partly or completely in one or more states should produce the Nativity Certificate along with true copies of their parent's certificates such as Birth Certificate / SSLC /HSC /Transfer Certificate and Ration Card / Passport to substantiate their place of birth in Tamil Nadu, to establish the relationship between the parent and the candidate along with the Nativity Certificate of the candidate.
- e) The Certificate of Nativity in Tamil Nadu of the candidate should be issued by the competent authority only and supported by a copy of Passport / Aadhar / Voter's ID/ Driving License. If the copy of the supporting document is not produced, then the application will be summarily rejected.
- f) Candidates who are native of Tamil Nadu alone will be considered for communal reservation.
- g) Other State candidates who are not native of Tamil Nadu but who have Studied 8th standard to 12th standard and studied Diploma in Pharmacy course in Tamil Nadu will be treated as OC (Open Competition)

Note:

Producing false nativity certificate if detected at any time later during the course of study will result in expulsion of the candidate and also initiation of criminal proceedings against the candidate as well as the Parents as per law.

4. EDUCATIONAL QUALIFICATION:-

- a. Candidates should have passed in H.S.C. qualifying Examination conducted by the Tamil Nadu State Board or any other equivalent examination.
- b. Candidates should have passed Diploma in Pharmacy course.

5. MINIMUM ELIGIBILITY MARKS.

i. (a) For OC/BC/BCM/MBC/DNC CATEGORIES:-

Candidates should have aggregate of 40% marks in the first and second year D.Pharm. Examination with a pass in H.S.C.

(or)

Individual pass mark in Physics, Chemistry, Biology or Botany & Zoology or Mathematics both in theory and practical with not less than 40% aggregate marks in the above subjects in the qualifying H.S.C. examination (Academic stream) with a pass in D.Pharm Course.

(b) For SC/SCA/ST CATEGORIES:

Candidates must have obtained individual pass marks in Physics, Chemistry, Biology or Botany & Zoology (or) Mathematics both in Theory & Practical with a minimum of 35% marks in the above subjects with a pass in D. Pharm Course.

ii) Candidates who have passed Diploma in Pharmacy should have completed 500/750 hours of practical training **on or before 31.08.2019** and should have obtained the provisional certificate for having passed the Diploma Examination.

III. PROCEDURE FOR FILLING AND SUBMISSION OF APPLICATION:-

- 6a. The candidate should log on in any one of the following websites: www.tnhealth.org /www.tnmedicalselection.org
- b. Candidates should submit their filled-in online application form by uploading the details in the required fields.
- c. Request for change in any particulars in the online Application shall not be entertained under any circumstances after submission.
- d. Incomplete applications will be rejected.
- e. Candidates are advised to submit only one Application Form. If a candidate submits more than one Application Form, his candidature will be cancelled.
- f. Candidates should ensure that all information's entered in the online application are correct during the online submission of application form.
- g. Candidates should submit the print out of the filled-in online application form (Hard Copy) along with necessary enclosures.
- 7. All the entries in the online application form should be correct. The candidate should ensure that all information including the marks in the qualifying examination furnished by him/her in the application and the enclosures are same. The candidate is informed that if after scrutiny of his / her application it is found that the marks furnished by him / her in the application are not correct or any other information is found to be incorrect, then;

- a. He/she will forfeit the admission no matter at what stage of the course he/she will be at that time.
- b. He/she will be debarred from pursuing any studies for a period of two years.
- c. Legal action will be initiated against him / her for furnishing incorrect information.
- d. Criminal action will be initiated against him / her for furnishing bogus mark sheets / bogus Community certificate/false nativity certificate.
- 8. Candidates are instructed to enclose **only the photocopies (not original)** of the following certificates in the order indicated below along with the filled online application form.
 - a) HSC mark sheet
 - b) D.Pharm mark sheet(s)
 - c) Transfer certificate obtained after the completion of D.Pharm. Course.
 - d) Nativity Certificate (if applicable)
 - e) Permanent Community Certificate Card (if applicable)
 - f) 500 / 750 hours of practical training certificate.
 - g) Provisional Certificate / Diploma in Pharmacy certificate
 - h) Permanent Registration Certificate.
 - i) Service certificate in respect of Govt. servants completing 2 years continuous regular service **as on 31.5.2019**

9. FOR SERVICE CANDIDATES:-

- a) D.Pharm. qualified candidates who are serving in Tamil Nadu Medical Services will be treated as Service candidates for selection under the seats reserved exclusively for service candidates.
- b) Service candidates serving in Tamil Nadu Medical Service on a regular basis should have completed **two** years of service as on **31.5.2019** excluding the leave for which the candidate is eligible/availed other than casual and compensatory leave alone will be considered.
- c) D.Pharm. qualified candidates who are approved probationers serving in local bodies will be considered as service candidates and must have completed 2 years of service as on 31.05.2019.
- d) Service candidates should send their application through the Head of the Medical College Hospital/ Institution in which they are presently working.
- e) Service candidates taking allotment in Self-financing colleges will not be paid salary and they have to avail leave to which they are eligible for the period of study on their own after obtaining prior permission from their Head of the Department concerned.
- f) Candidates who are serving purely under "temporary category" in Tamil Nadu Medical Service will be considered for selection under open quota as <u>non-service candidates</u> only.
- 10. All Candidates from other Universities have to produce **Eligibility Certificate from the Tamil Nadu Dr. MGR Medical University**, Chennai-600 032 at the time of counselling.

IV. MERIT LIST

- 11. a. The merit list for B.Pharm.(Lateral Entry)Course will be prepared by computing the marks obtained in D.Pharm. course.
- b. It will be reduced to the base of 100 marks. The marks will be accurate to two decimals.
- c. The Secretary, Selection Committee will publish the merit list at the Selection Committee, Directorate of Medical Education, Kilpauk, Chennai 10 and the same will be available in the website: www.tnhealth.org/ www.tnmedicalselection.org

d. Determination of Inter-se-merit:-

In cases, where two or more candidates obtain equal marks, the rank of such candidates shall be determined on the basis of the following order:-

- (i) No. of attempts in D.Pharm. course.
- (ii) Date of Birth weightage given to seniority in age.

V. COUNSELLING PROCEDURE (SINGLE WINDOW SYSTEM):-

- 12. a. Admission to B.Pharm (Lateral entry) course, shall be made by counseling on the basis of merit applying the rule of reservation.
- b. One of the parents will be allowed to attend the counseling.
- c. Any change or modification and relevant information pertaining to admission process will be made available immediately on the websites www.tnmedicalselection.org. The candidates are instructed to visit the website from the date of commencement of online application till the end of counselling without fail. All information including the date of counselling will be put up in the websites. Call letter can only downloaded from the websites. Candidates will be permitted for counselling accordingly.
- d. Candidates who fail to attend the counselling session when called for by the Secretary, Selection Committee, has to forfeit his / her right to claim admission to B.Pharm. (Lateral Entry) course and his / her name will not be considered further. However, the Selection Committee reserves the right to permit the candidate to attend the subsequent counselling session, if a valid reason for absence is communicated to the Selection Committee before the commencement of the counselling. The candidate so permitted can only choose college available at the time of counselling when he / she actually attends.
- e. The candidate and parents accompanying them should make their own arrangements for the counselling.

- f. If a candidate chooses a Govt. quota seat in Self-Financing Colleges category when seats are available in Government Colleges, he/she has to give a declaration to that effect.
- g. If there are no eligible D.Pharm. qualified Service candidates opting for B.Pharm (Lateral Entry) course, the same will be allotted to eligible Non-Service candidates.
- h. If there are no eligible D.Pharm. qualified Non-service candidates opting for B.Pharm (Lateral Entry) course, the same will be allotted to eligible Service candidates.
- i. All selections for B.Pharm (Lateral Entry) course are only provisional. The Selection and admission is liable to be cancelled at any time as and when the eligibility conditions are found to be defective.
- j. As per G.O.Ms.No.361,H&FWDept.,dated:17-10-2000 10% of the total seats in B.Pharm course sanctioned in Government and self financing colleges are reserved for lateral entry candidates.
- k. All the candidates attending the counselling for B.Pharm (Lateral Entry) Degree course will have to remit a non-refundable amount of Rs. 250/- by means of Demand Draft drawn in favour of "The Secretary, Selection Committee, Kilpauk, Chennai-10" as processing fee.

VI. METHOD OF SELECTION AND ADMISSION:-

- 13. (i) Out of the seats sanctioned for B. Pharm (Lateral entry) course, 50 % seats in each college are reserved for service candidates in addition to those service candidates selected under the open category. In case an odd number of seat remains in any college out of the total seats sanctioned for that college, that seat shall be filled by merit and communal reservation.
- (ii) Selection & Admission will be made on merit basis for all categories of seats in B.Pharm, (Lateral Entry) course, counselling according to choice of the candidates and availability of seats following the rule of reservation / Roster method followed by the Government of Tamil Nadu whichever is applicable.

 No change of college will be entertained after allotment.
- (iii) Any remaining unfilled seats for want of adequate number of eligible candidates belonging to SCA community shall be filled by candidates belonging to SC community other than Arunthathiyar as per merit and vice versa. (G.O. (Ms) No. 55 P & AR Department dated:08.04.2010)
- (iv) Any remaining reserved seats in ST Quota for want of adequate number of eligible candidates belonging to ST community shall be allotted to candidates belonging to SC Community as per merit. (G.O.(Ms) No.77 Health & Family Welfare Department (MCA1) dated 24.02.2011)
- (v) Any remaining unfilled seats in BCM Community for want of adequate number of eligible candidates after exhausting the merit list shall be filled

- up on merit basis by candidates belonging to BC community without exceeding the quota for BC community as a whole(G.O.(Ms).No.30/H&FW Dept(MCA1)/dated 18/01/2012)
- (vi) Even after filling up of the required seats reserved for Arunthathiyars on preferential basis, if more number of qualified Arunthathiyars are available, such excess number of candidates of Arunthathiyars shall be entitled to compete with the Scheduled Castes other than Arunthathiyas in the inter-se merit among them (As per G.O.(Ms).No.65, dated:27.07.2009 of P &AR(K) Department).
- VII. CATEGORIES OF SEATS:-
- 14. i. CATEGORY I-GOVERNMENT COLLEGES:-
 - 1. Madras Medical College, Chennai.
 - 2. Madurai Medical College, Madurai.
 - ii. CATEGORY II SELF FINANCING INSTITUTIONS: -

Note: 10% of the total number of seats sanctioned for B.Pharm course are earmarked for B.Pharm (Lateral Entry) candidates both in Government and Self Financing Institutions.

- (a) Selection and admission of students to the seats earmarked as Govt. Quota in Self-Financing Institutions will be subject to the rules proposed by the Govt. coming into force before Counselling. The Seat matrix for these institution will be displayed during Counselling.
- (b) The fee structure will be adopted as fixed by Committee appointed by the Government of Tamil Nadu for this purpose.

VIII. SPECIAL CATEGORY: -

- 15. Seats reserved for Orthopaedically Physically disabled in B.Pharm (Lateral Entry) Course:-
- (a) 5% of the total number of seats available in Government Colleges are reserved for the Orthopaedically Physically Disabled candidates. The first preference in the reservation of the seats, candidates with disability of lower limbs between 50% to 70% shall be considered and in case candidates are not available in that category, then candidates with disability of lower limbs between 40% to 50% may be considered. The other conditions for admission into B.Pharm (Lateral Entry) course will be applicable as in case of the general category.
- (b) The candidates are required to produce a certificate from the District Medical Board of the area concerned constituted for this purpose assessing the nature and the extent of the Physical Disability in the format prescribed in the Annexure III (a) & (b).
- (c) The Medical Certificate issued by the District Medical Board of the area concerned for this purpose is subject to the confirmation of the Expert

- Committee constituted by the Director of Medical Education at the time of Counseling.
- (d) The candidates seeking admission under this category should produce a full size photograph exhibiting the deformity.
- (e) The certificate must have been obtained within three months prior to submitting the application for seeking admission under this category. If the Certificate has been obtained earlier, the application will be rejected.

Note:

- 1) The selected candidates for B.Pharm (Lateral Entry) Course will be required to undergo second Medical Examination by a Medical Board constituted for the purpose by the Director of Medical Education to ascertain and confirm their nature and extent of physical disability.
- 2) Candidates with any other disability other than the locomotor disability of the Lower limb will not be considered for admission to B.Pharm (Lateral Entry) Course under the Special Category. Such applications will be summarily rejected without any intimation to the candidate.
- 3) The decision of the Director of Medical Education in this regard will be final.
- 4) Candidates who previously applied for B.Pharm (Lateral Entry) course under Orthopaedically Physically Disabled Category and were rejected by Special Medical Board constituted by the Director of Medical Education for this purpose are not eligible to apply under this category. Such application will be summarily rejected. As per G.O. (Ms).No.200, Social Welfare and Nutritious Meal Programme Department, dated 22.12.2006, it has been ordered that for every 33 vacancies one disabled person is to be selected and the candidate is to be placed against his / her community in the communal roster.
- 16. (i) The candidates belonging to BC, BCM, MBC/DNC, SC, SCA and ST communities should submit a xerox copy of the community certificate issued by the competent Revenue authority of the area concerned. The candidates who belong to Scheduled Tribe should submit a xerox copy of the permanent community card obtained from the respective Revenue Divisional Officer of the Revenue Division.
 - (ii) Community certificate obtained from other states will not be considered and such candidates will be treated as open category.
- IX. DURATION OF THE COURSE:
- 17. B.Pharm. (Lateral Entry): 3 years

X. FEE DETAILS:-

18. (i) Fee Payable after admission to B. Pharm (Lateral Entry) Tuition Fee Per Annum

^{*} As per the Fee Committee proceedings dated 14.08.2014, the above fee does not include Hostel, Transport/Mess charges, etc.

(ii) SC/SCA/ST candidates are exempted from payment of tuition fee. Candidates who have been selected under Orthopaedically physically disabled category are also exempted from paying Tuition fee and Special fee.

Students of SC /SCA/ ST community, whose Parents / Guardian's annual income is less than ₹2,50,000/- (Rupees Two Lakhs and Fifty Thousand Only) and for SC converted Christianity students whose parents/ guardians annual income is less than Rs.2,00,000/- (Rupees Two Lakhs Only) are exempted from payment of all compulsory, non- refundable fees (Enrollment/ Registration, Tuition, Games, Union, Library, Magazine, Medical Examination and such other fee compulsorily payable by the scholar to the Institution or University / Board) and also exempted from all compulsory Non refundable fee fixed by the Fee Committee. The fee, so exempted shall be claimed by the respective Institutions under the Scholarship Programme of the Government of India. (As per G.O.(Ms) No.6 AD and TW Dept. dated 09.01.2012 and G.O.(Ms) No.51, Adi Dravidar and Tribal Welfare Department, dated 7.8.2013) and as per G.O.(Ms).No.92/AD and TW Dept. dated 11.09.2012

- 19. The Selected Candidates will have to produce the original mark-sheet of the qualifying examination and other original documents, such as proof of age, certificate of social status, transfer certificates, etc., at the time of admission to the Deans of the Medical Colleges/ Institutions concerned. Selection will be cancelled if the candidates do not produce all the original documents and the original transfer certificate.
- 20. The candidates will require to undergo Medical Examination at the College to which they are allotted before the Medical Board on the date notified by the authorities of the College. Only those candidates found medically fit will be admitted and be permitted to pay the fee.

- 21. Candidates selected for admission and his / her parent / guardian will have to sign a discipline declaration form (**Annexure-IV**). Failure to sign the declaration will result in cancellation of selection.
- 22. Candidates selected for admission to B.Pharm. (Lateral Entry) course are not guaranteed any appointment in Government service.
- 23. The candidate shall diligently complete his / her training for the said course at the said college, shall abide by the rules of the said college for the time being in force regulating the conduct of students at the said College and shall pass all the examinations prescribed for the said course by the University or the Medical Institution concerned.
- 24. The Government orders issued and to be issued from time to time pertaining to any of the matters contained in the prospectus should be read as part and parcel of this prospectus and such terms and conditions in the Government order are deemed to have been incorporated in the prospectus.

25. **DISCONTINUATION FEE:-**

The candidates who are allotted and joined in any of the seats in Govt. Medical Colleges and discontinue the **B. Pharm (Lateral Entry) after the cut-off date** should pay the Discontinuation Fee of Rs. 1,00,000/- (Rs. One Lakh only) by means of Demand Draft in favor of "The Secretary, Selection Committee, Kilpauk, Chennai – 10" payable at Chennai

26. **Hepatitis-B-Vaccination:** -All candidates selected for admission to Lateral B.Pharm. course should take the Hepatitis – B vaccine before admission and produce a certificate as in Annexure – II.

27. Ragging:-

The candidates who join B.Pharm (Lateral entry) course should not indulge or participate in any kind of ragging throughout their study period. If they are found to have indulged in ragging at any time, the candidate will be removed from the roll of the Institution at whatever stage of study and criminal action will be taken against the candidate.

28. Candidates who have applied for B.Pharm (Lateral Entry) course are deemed to have read the contents in the prospectus and agreed with all the conditions / clauses and will not have the right to challenge any of the clauses contained in the prospectus.
