1. The Panimalar Medical College Hospital & Research Institute, Chennai has approached the committee for fixing the fee for their college. Though the institution seeks for fixation of fee at Rs. 35,00,000/- lakhs Per Student, we are unable to fix the same. It is true that the college is having all facilities more than the norms prescribed by the MCI. However considering the present position all over the world due to COVID -19, we are inclined to fix the fees as was fixed to other medical colleges for the present academic year 2020 -2021.

**ORDER:-**

1. The Committee fixed the following fees all including Tuition fee, Admission fee, Special fee, Laboratory / Computer / Internet fee, Library fee, Sports fee, Maintenance and Amenities fee, extracurricular activities fee, and other recurring expenditure, for other colleges.

<b>a. Government Quota</b>	<b>-Rs. 4,00,000/-</b>
<b>b. Management Quota</b>	<b>-Rs. 12,50,000/-</b>
<b>c. NRI Quota</b>	<b>-Rs. 23,50,000/-</b>
<b>d. NRI Lapsed</b>	<b>-Rs. 20,50,000/-</b>

Thus the same fee is fixed for Panimalar Medical College Hospital and Research Institute, Chennai

2. The maximum fee structure prescribed will take effect for the students admitted for the academic 2020 -2021 only.
3. In addition to the above fees, the institution is permitted to collect an amount of Rs.25,000/- per student as development fee.
4. The management is directed to cover all the Students under Students Group Insurance Scheme.
5. The above fee does not include Hostel, Transport, and Mess charges which is optional for the students.
6. The Committee directs that the institution shall not collect or levy any other recurring or non-recurring fee including capitation fee.
7. Any deviation from this order of the committee will entail serious penal consequences like withdrawal of approval by MCI and disaffiliation by the concerned University as well as imposition of fine

8. It is also recommended that the Government of Tamil Nadu should frame a scheme to provide financial assistance to the poor meritorious students to the extent of 15% of the students admitted in the institution belonging to SC, ST, and MBC Community.
